

("Citizens"), parent company of Citizens Bank of Lafayette, have entered into a definitive agreement providing for the merger of American with and into Citizens.

Subsequent to the merger, American Bank & Trust will become a part of Citizens Bank of Lafayette while American Bank & Trust's offices will continue to operate under their current name for a period of time. The transaction, which has been unanimously approved by the boards of directors of Citizens and American but remains subject to customary closing conditions including receipt of regulatory approvals and approval by American shareholders, is expected to close in the fourth quarter of 2020.
